7. Presentation of 2020-21 Business Plan and Budget

The aims of IAF are to:

- promote and defend authors' interests and authors' rights including both moral and economic rights.
- actively work in favour of balanced contractual legislation that guarantees fair practices for authors and ensures that authors retain their economic and moral rights against buyouts and other unfair practices.
- advocate the author's role in society, pointing out the importance of creation for cultural diversity and the economic value which authors create.
- provide authors' organisations worldwide with an international platform to exchange information, develop positions and provide support in authors' rights matters.
- promote the benefits of authors' rights in general and of collective management in particular in order to ensure that authors
 always receive fair and equitable remuneration whenever their works are exploited by third parties.

Internal Structure of IAF

Key responsibilities continue to be covered by Luke Alcott (Secretariat) and Barbara Hayes (Company Secretary). In the last year, ALCS staff members Jacqui Dalton, Alice Donovan and Esther Jones have provided assistance with administration and communications. From 24th February 2020, IAF has recruited Athanasios Venitsanopoulos as Campaigns and Advocacy Assistant on a one year fixed term contract.

The IWC includes an authors' gathering within IFRRO enabling author representatives both within and outside IAF to discuss common issues and authors' position in relation to IFRRO's work. During the meeting we will also hold an IAF meeting/drinks reception for the IAF Steering Committee and authors' representatives who are also at the IFRRO meetings, to discuss current issues and IAF's latest work.
